#### **SITUATION**

The premises, which are situated in the heart of the Little Germany Conservation Area occupy a prominent corner location at the junctions with Burnett Street and Peckover Street, the latter being the main spine road running through this historically acclaimed area. Ease of access is available to Leeds Road (A647), Shipley Airedale Road (A650) and the City Centre.

A number of upmarket apartment schemes have been developed in recent years, with the area also popular with office occupiers (Chamber of Commerce, Schofield Sweeney Solicitors, Grattan plc etc.)

## PROPERTY/ACCOMMODATION

The property comprises an attractive 2/3 storey Grade 2 Listed building with fair faced stone elevations under a pitched/hipped blue slated roof. Many of the original features have been retained (stone detailing to the elevations, ornate arched lintel above main entrance etc).
